
**Section 551.072:** For the purpose of discussion with respect to the purchase, exchange, lease, or value of real property, if deliberation in an open meeting would have a detrimental effect on the position of the Court in negotiations with a third person. **Section 551.073:** For the purpose of deliberation regarding prospective gifts or to deliberate a negotiated contract

for prospective gift or donation to the Court or Walker County ESD#2, if deliberation in an open meeting would have a detrimental effect on the position of the Court in negotiations with a third person. **Section 551.074:** For the purpose of considering the appointment, employment, reassignment, duties, discipline, or dismissal of a public officer or employee or to hear complaints or charges against a public officer or employee, unless such officer or employee requests a public hearing.

**Section 551.076:** To discuss the deployment, or specific occasions for implementation of security personnel or devices. **Section 551.086:** Deliberation regarding economic development negotiations.
