Section 551.072: For the purpose of discussion with respect to the purchase, exchange, lease, or value of real property, if deliberation in an open meeting would have a detrimental effect on the position of the Court in negotiations with a third person. **Section 551.073:** For the purpose of deliberation regarding prospective gifts or to deliberate a negotiated contract for prospective gift or donation to the Court or Walker County ESD#2, if deliberation in an open meeting would have a detrimental effect on the position of the Court in negotiations

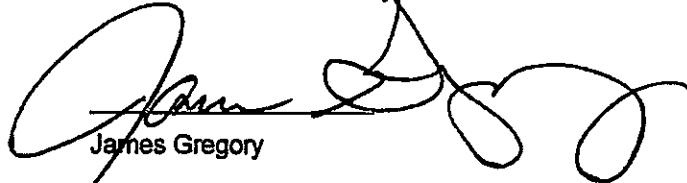
