**IX. EXECUTIVE SESSION:**


If during the course of the meeting covered by this notice, Court shall determine that a closed meeting of the Court is required, then such closed meeting as authorized by Texas Government Code 551, sub-chapter D will be held by the Court may conveniently meet in such closed meeting concerning any and all subjects and for any and all purposes permitted by Chapter 551, sub- chapter D, inclusive of said Texas Government Code, including but not limited to: **Section 551.071:** For the purpose of private consultation between the Court and its attorney when the Court seeks the attorney's advice with respect to pending or contemplated litigation settlement offers, and matters where the duty of the Court counsel to his client pursuant to the Code of Professional Responsibility of the State Bar of Texas clearly conflicts with the Open Meetings Act.

**Section 551.072:** For the purpose of discussion with respect to the purchase, exchange, lease, or value of real property, if deliberation in an open meeting would have a detrimental effect on the position of the Court in negotiations with a third person. **Section 551.073:** For the purpose of deliberation regarding prospective gifts or to deliberate a negotiated contract for prospective gift or donation to the Court or Walker County ESD#2, if deliberation in an open meeting would have a detrimental effect on the position of the Court in negotiations with a third person. **Section 551.074:** For the purpose of considering the appointment, employment, reassignment, duties, discipline, or dismissal of a public officer or employee or to hear complaints or charges against a public officer or employee, unless such officer or employee requests a public hearing.

**Section 551.076:** To discuss the deployment, or specific occasions for implementation of security personnel or devices. **Section 551.086:** Deliberation regarding economic development negotiations.
